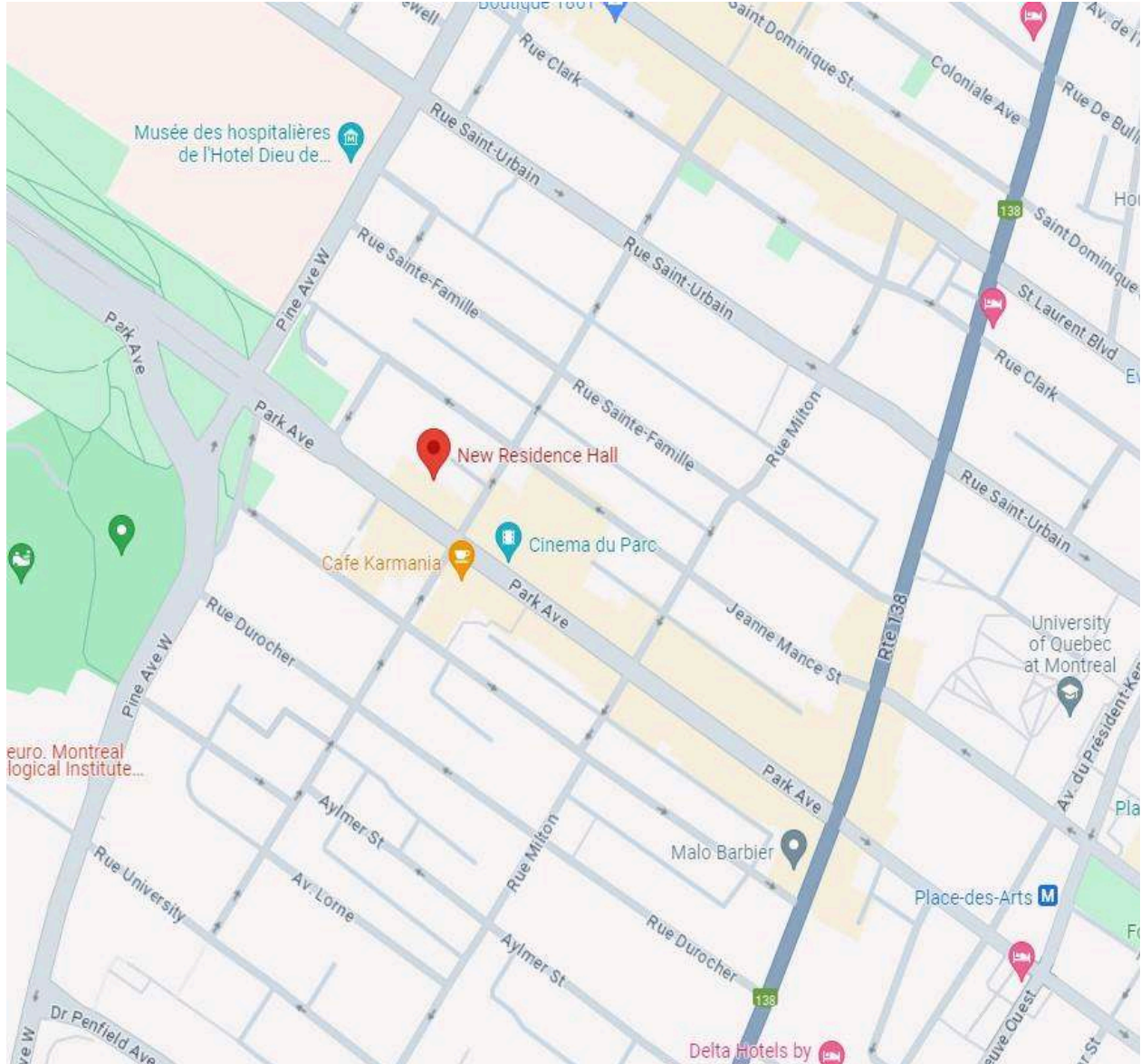

It posits that about 70% of the global labour force within the rural communities have no access to accessible and quality healthcare. Self-medication which is an alternative to traditional and formal medical pathways is the recognized in most rural settings. Health Entrepreneurship which is a home-grown job creation and self-employment avenue for local health provision is considered the most sustainable and surest guarantee for improving the bizarre health situation and the endemic rural poverty situation. This entails using appropriate local skills and technology to solving the very basic health and social challenges. Countries like Rwanda, Ghana, Mauritius and Botswana are living testimonies to this. The United Nations Conference on Trade &amp; Development 2020 (UNCTAD) report on rural health status sees local health entrepreneurship as a panacea to the canker of rural poor health situation and the endemic poverty.
